A Guide to Individual Plans

If you need extra help in school, it may mean you have Additional Learning Needs (ALN).

Children with Additional Learning Needs (ALN) need extra help to learn. This may be because they have a learning difficulty or disability. They find it harder to learn than other children the same age.

If you have ALN you will have an **individual Development Plan (IDP)**







IDP: Individual Development Plan. Agreed plan of who, what and how you will be supported.

Designated Coordinator An adult in school who knows you well will help you and answer any questions you have about ALN and IDPs. This person is called a Designated Coordinator. Your school or Local Authority will decide whether you have additional learning needs which requires a little extra help at school. If you do, you will have an IDP.

Plans are usually written by schools with you, your family and other people who know you. Sometimes the plans will be written by the Local Authority.

If a school writes the IDP it can take 7 weeks. If the LA writes the plan it can take 12 weeks.

The plan has to be reviewed within a year or if something has significantly changed in your life. Review means the plan will be looked at again to make sure it is still working and if changes are needed.

Speak to your Designated Coordinator or class teacher in school.

A case friend can help you. A case friend can be a close friend, family member, social worker or teacher.
